

DERRY TOWNSHIP SPECIAL MEETING

The Derry Township Board of Supervisors held a Special Meeting, Tuesday, December 30, 2025 at 4:00 p.m., Township Municipal Building, 73 Reserve Lane, Lewistown.

Chairman Napikoski called the meeting to order at 4:00 p.m. The purpose of the special meeting was to consider adoption of two Ordinances that had been duly advertised, both on December 16, 2025.

VISITORS: Sierra Bolger, Lewistown Sentinel, attended the meeting via Zoom. Joseph Ughetto, II, was also in attendance.

PUBLIC COMMENT: None

OLD BUSINESS: None to be considered.

NEW BUSINESS:

D. Warntz made a motion to approve adoption of Ordinance 2025-2, amending Part I, ("Administrative Legislation"), Chapter 49 ("Salaries and Compensation"), Section 49-1 ("Compensation") to set the compensation of members of the Board of Supervisors to \$4,190 per year, the salary increase becoming effective at the beginning of the next term of each Supervisor.

J. Sipe seconded the motion. Roll call vote: R. Napikoski, aye, D. Warntz, aye, J. Sipe, aye. Motion carried 3 - 0.

J. Sipe made a motion to approve adoption of Ordinance 2025-3, amending Chapter 172 ("Sewers and Sewage Disposal"), Article III ("Sewer Use, Rents, and Charges"), Section 172-18 ("Sewer Rentals or Charges") of the Township Code to increase each private dwelling's sewer rate to \$159 per quarter or to \$636 per annum; to increase the sewer rental fee for all owners of non-residential, improved properties connected to the sewage collection system to \$15.00 per 1,000 gallons of water consumed; removing references to residential sewer rates for the South Hills Sewer District in the Township; and removing an example calculation of sewer fees from the ordinance; and amending Chapter 172 ("Sewers and Sewage Disposal"), Article III ("Sewer Use Rents and Charges"), Section 172-19 ("Time and Method of Payment") of the Township Code of Ordinances to increase the minimum rental charge fee to \$105 per quarter for any unit in the Township where there is a vacancy for a full quarter. D. Warntz seconded the motion. Roll call vote: R. Napikoski, aye, D. Warntz, aye, J. Sipe, aye. Motion carried 3 - 0.

There being no further business, J. Sipe made a motion to adjourn at 4:05 p.m. R. Napikoski stepped from the chair and seconded the motion. Motion carried 3 - 0.
