CAMPGROUND RULES & REGULATIONS

When you arrive...First Come/First Serve

Choose a site and set up.

Please pay Park Staff for full stay when entering the campground or in Honor Envelope and deposited in the Key Drop Box at the Campground Bathhouse.

We accept checks, cash and credit cards (additional fee will be applied),. (\$50 fee for returned checks)

Rules & Regulations

THIS CAMPGROUND DOES NOT OFFER SEASONAL OR LONG-TERM CAMPING.

Campers may stay in the campground for up to 14 consecutive nights. If you wish to stay for a longer period, you must fill out an Extended Stay form and get approval from Derry Township. The request for an extension must be submitted at least 7 days prior to your next extension period. No more than 28 consecutive night stays will be granted per year to anyone. You may not return to campground for 14 days after a 28 consecutive night stay. You must be in good standing with Derry Township to be considered for an extension.

Site occupancy is limited to one unit per site, with one responsible adult over the age of 18 staying on site. A limit of 8 registered people per site. One additional tent may be set up on site if space permits. All campers and vehicles must be registered and listed on the campground registration form.

- Speed limit is 5 MPH throughout the park and campground.
- Registered vehicles only. Limit of two vehicles are permitted at a campsite. Additional parking is available.
- No repairs may be made to vehicles on site aside from emergency repairs.
- Visitors are permitted from 8 am to 10 pm.
- ALL visitors must park in the designated parking areas outside of the campground.
- Visitors are limited to no more than 6 people in addition to those registered per site. There are pavilions available to rent for large gatherings.
- NO PARKING in grassy areas anywhere in park.
- No bicycles are permitted on park grounds.
- Quiet hours are from 9 pm to 8 am. Please refrain from loud noises and disturbances during this period. During quiet hours lower voices. If you can hear stereos, tv's, radios, etc., outside of your tent/camper, it is too loud. During other times, these devices should be kept at a reasonable level so as not to disturb other campers.
- Pets are allowed. MAXIMUM of 3 pets allowed per site. Pets must be leashed at all times. Pet litter must be picked up immediately. CAMPERS WHO DO NOT PICK UP AFTER THEIR PETS WILL BE ASKED TO LEAVE-NO REFUNDS-NO EXCEPTIONS!

- Pets are not to be left unattended at anytime. Barking or growling dogs will not be tolerated. Upon a complaint of noise, one warning will be issued by park staff. In the event such barking or roaming or any other infraction continues, the Camper shall either remove the pet from the campground or shall leave the campground immediately.
- Visitors MAY NOT bring pets to the camping area.
- Alcoholic beverages are not permitted on Park grounds and must be kept on your campsite while camping. Drunkenness, impaired or under the influence, loud or disorderly behavior will not be tolerated. No one under 21 will be allowed to possess or consume alcohol in the campground.
- Fires are only permitted in designated fire rings. Fire rings must stay in place on site.
- Fires must NOT be left unattended. We reserve the right to monitor the size of the fire.
- All fires must be extinguished before retiring or before leaving the site.
- Gray water should be disposed of in the sanitary dump station.
- Personal Property – All personal property brought into the campground is at the Registered Camper's risk and campground management shall bear no responsibility for the damage, loss or theft of such property. We are not responsible for any damage to any camper or personal property for any reason including an act of God (i.e. wind, lightning, hail, fallen branches, trees, embers that drift onto property, etc.) accident, fire or vandalism.
- Personal items (i.e. tents, chairs, camping supplies, etc.) will be disposed of after 14 days after a reasonable attempt is made by the Township to contact the registered campers.
- The use or display of fireworks, explosives, and use of illegal drugs or substances is strictly prohibited. The tossing, throwing, etc. of rocks, stones or other objects is prohibited. VIOLATION OF THIS RULE WILL RESULT IN IMMEDIATE EVICTION AND REMOVAL OF YOUR PERSONAL EFFECTS AND NOTIFICATION OF THE PROPER AUTHORITIES FOR PROSECUTION.
- Campers staying in the Campground may use dump station free of charge, all others must pay a \$10.00 dump fee.
- Firewood may be purchased and delivered by the Park Staff for \$20.00 load during the hours of 6 am to 1:30 pm. (Monday – Friday)
- Firewood after hours may be purchased at the Mini Golf for \$10.00 a wagonload during their regular hours.
